In terms of section 5 of the Public Audit Act (PAA), the Auditor-General of South Africa (AGSA) invites applications from suitably qualified persons to serve as panel members on the advisory committee for material irregularities (ACMI).

- The ideal candidates should preferably have public sector experience.
- All possible candidates across the country are encouraged to apply.
- Applicants must be South African citizens and must have the best interest of the AGSA at heart.
- All members of the committee must be independent from the AGSA and may not render contracted audit or other services to the AGSA or any auditee that may become subject to a certificate of debt.

Members of the committee may not be employed by auditees of the AGSA or serve as accounting officers or members of accounting authorities in South Africa.

Relevant progressive work experience of at least 10 years in law, ISA240-related experience, forensics in the public sector. Experience in supply chain management would be an added advantage.

For this specific vacancy, the panel member should be an attorney or advocate. As most cases will involve work related to auditing, accounting and ethics, and will be conducted through general legal principles, a sound and thorough understanding of these disciplines is required. Experience in advisory, governance and/or disciplinary structures (mainly in public sector) and a legal expert well versed in company law (duties and liability of directors), fiduciary duties of accounting officers and authorities, public law and/or administrative law to act as the chairperson. More than 20 years' experience in the legal fraternity.

KEY DUTIES OF ACMI

- Hearing of oral representations made by the accounting officer, accounting authority or those members of that accounting authority relating to the material irregularity.
- Submitting findings and recommendations on the oral representations made by that accounting officer, accounting authority or those members of that accounting authority for consideration by the auditor-general.
- Question or require explanations in respect of any issues relevant to the matter before the ACMI.

TERMS OF OFFICE:

- Members of the ACMI panel will be appointed by the auditor-general on a part-time basis for a period of three years, which may be renewable once (i.e. maximum six years).
- The auditor-general, in his/her sole discretion and as he/she deems necessary, will invite any one or more members of the panel, to attend an oral representation hearing.

APPLICATION PROCEDURE – NOTE:

- Applications must be submitted in writing, indicating which position is being applied for, and must contain at least the following: detailed curriculum vitae, motivation for appointment, a certified copy of identity document and qualifications obtained and at least two references demonstrating knowledge or experience application in the applicant's selected field.
- Background verification, including criminal record and citizenship checks will form part of the selection process.
- Preference will be given to candidates whose appointment will enhance representivity.
- Correspondence will be limited to shortlisted members only.
- Candidates must complete the attached declaration of conflict of interest.
- No late applications will be accepted.
- Strict compliance with the application requirements and selection procedure will be adhered to.

Eligible persons who wish to be considered for appointment are invited to motivate in no more than 200 words why you feel that you are suitable. Please include experience and qualifications in your motivation.
